Qualitative analysis of Criterion 1

Bharata Mata College runs 15 UG, 6 PG, and 3 PhD courses on its main campus located at Seaport Airport Road, Thrikkakara Kerala. This college has ensured the effective curriculum delivery focusing on the three steps: (i) implementing the 3-year strategic plan, (ii) annual academic plan, and (iii) graduate-attribute-linked course plan. While finalizing the 3-year strategic plan, they take the feedback from stakeholders. Based on this, the academic plan is carried out. The POs, PSOs, and COs are an integral part of the third step. Teacher's diary and monitor's diary are interesting implementations by the college.

The college offers bridge courses to new students, advanced coaching and mentoring is provided to all the students in the college with a motive to increase their employability. This college introduced 34 new certificate/diploma courses in the last 5 years, 22 faculty members were involved in BoS/Academic Council activities in the same period. The faculty members are also serving on the BoS of other universities in the state.

The college introduced 293 new courses (as a mandate by MG University) in the last 5 years. In 21 programmes, the college has introduced the CBCS system. In the last 5 years, this college has awarded a certificate/diploma to as many as 2,031 candidates. In the year 2017-18 itself, 831 such candidates got benefitted. The college has claimed the organisation of 20 value-added courses in last 5 years. Quite a good number of the students go for the field project while pursuing their programmes in this college. The college has a feedback system which needs to be strengthened.

The courses that might help the students in getting sensitised with the cross-cutting issues relevant to gender, environment and sustainability, human values and professional ethics need to be strengthened. For the overall development of the students, the college administration does travel extra miles by offering add-on courses.

Bharata Mata College has a healthy enrolment ratio, approximately 90% of the seats in the college are filled. The highest enrolment ratio of 100% is achieved in all PG courses and the lowest enrolment is in BSc Mathematics course. The number of students from other states/countries is towards a lower side, the college administration should possibly work on this. The applicable reservation is being followed in the college, and 89.1% of the reserved seats were offered to the eligible candidates.

The admission process is done by the MG University, centrally. For the management quota, the students are selected as per their merit ranking in qualifying programme. This college also conducts an Entry Level Test after admissions to know their learning capabilities. An orientation program is organized by the college with the help of experts for the first-year students.

The college takes care of the progress of slow and advanced learners. Slow learners are given extra care in the form of remedial classes. Peer teaching is done in classes where high achievers help the low achievers. The fast learners are encouraged to have a research orientation in their progress by exposing them to relevant papers/projects, and through Walk With Scholar program. There are also initiatives for all the students such as appointment of a placement officer and improving their communication skills.

The student-teacher ratio at the college is 21.97, which seems to be high. College administration should work on attracting talented faculty. There are 7 differently-abled students enrolled in the college. This college has a

Wi-Fi enabled campus, the bandwidth needs to be increased. The faculty members plan their instructions well, using ICT tools, seminars, and assignments, etc. Bharata Mata college has 88.8% of the faculty members on regular rolls and 11.2% of the faculty members on contract rolls. The number of Ph.D. faculty is on a lower side.

This is interesting to note that the percentage of full-time faculty from other states is quite healthy when compared with the students from these areas.

This college has an internal examination committee that takes care of course learning outcomes, and programme objectives, etc. An online attendance system is in place in the college. The college has implemented the mechanisms for examination related grievances of students. The college follows a predefined academic calendar. The POs, PSOs, and COs are assessed through direct methods. The administration should focus on increasing the pass percentage of the students, 67.45% seems to be low.

The faculty members of Bharata Mata College received a sum of Rs. 111.01 lakhs as a research grant in the last 6.5 years. In the last 18 months, college has received During the year 2017-18, they could not attract any funding. The college administration should put in efforts for improving the situation. The number of recognized research guides in the college is 14, this again is towards a lower side. The notable efforts of the college towards research include publishing a peer-reviewed bi-annual journal, establishing research centers.

College did organize some research-oriented workshops to increase the knowledge base of students and faculty members in a few areas. This college also organized seminars/workshops on intellectual property rights and industry-academia interaction. The administration has also published an in-house document on the code of ethics to be followed by all the stakeholders. In order to increase the research activities on the campus, the college administration has implemented an incentive scheme for research publications. This should, however, be extended to all faculty members of the college.

In the last 6 years, 23 Ph.D. students graduated from college. The academic staff published 179 research papers in the last 6 years. The faculty members should focus on publishing in SCOPUS/SCI journals. The faculty are quite active in publishing book chapters in comparison with the research paper publication. The college staff is concerned about social development and has contributed to organizing a number of extension activities on this front, especially the NSS/NCC students in the college. This college has received awards three awards for their social outreach activities. Social work department of the college takes active participation in social activities/community services. A good number of activities have also been organized establishing the linkage between industry involving students. The college should, however, work on the faculty exchange also. A good number of MoUs have also been signed in the year 2017-18.

Bharata Mata College is located at an advantageous place, geographically. This has 66 ICT enabled classrooms, 11 science labs, 8 computer labs, and 1 language lab. The college has a total number of 246 computing machines. These are equipped with software required for the students. The entire campus is Wi-Fi enabled.

This college is fully solar-powered and has the capacity to generate 80 KW/hour, 5 hours a day making it 400 Units/day. The stakeholders are given enough space to work. The college also has 2 auditoriums with a capacity of 1500 and 300. The sports facilities on the campus needs to be maintained and improved. The same ground is used as athletics track, cricket ground, and football ground. There is a basketball court, and one badminton court (outdoor), and one gymnasium. The girl students are of the opinion to have more indoor games including Table Tennis.

Almost all the classrooms in the college are ICT enabled. The college pumps in a good amount in augmenting the infrastructure, and this is consistent in the last 5 years, except in the year 2016-17.

The library of the college is very suitably placed. It runs on the KOHA, an open-source integrated library system. It has a good number of print materials, and e-resources. The library also has a few rare books. The stakeholders can also access a few e-journals. The average expenditure on books and journals, in the last 5 years is Rs. 3.57 lakhs, this seems to be on a lower side.

The college has successfully oriented the campus and office activities towards integrating IT into everyday activities, connected through LAN. The administration is also in the implementation phase of an enterprise resource planning software. Some of its modules are completely functioning and some partially.

The college spends a good amount on improving its physical facilities and academic support facilities and has implemented the procedures for maintaining these facilities.

Bharata Mata College has an attractive fellowship programme for its students supported by Kerala/Central government. Approximately 35% of its students get a fellowship from government agencies. This number is, however, low when we consider the fellowship extended by the college itself. The administration should consider attracting better students through fellowships.

A good number of processes, including, preparations for competitive examinations, career counseling, workshops on soft skills, language lab, etc., are in place that helps students to increase their employment potential. A good number of students explore these facilities and got benefitted. This college, however, needs to pay more attention in improving the employability of its students. The college has helped the students in improving their communication skills.

The college has appointed a committee for the redressal of student's grievances including the cases related to sexual harassment and ragging. In 2017, 5 such cases have been handled. The placement percentage does not appear to be significant if we consider all the outgoing students. This percentage, however, is significant in the MBA course. There is a good number of students who opt for higher education and also who qualify the state/national/international level examinations. The students of this college have participated and won medals in various sport events. There are 6 students in University Cricket Team, 8 students in University Badminton Team, and 1 student in University Chess Team from the college.

The college also has a 2-tier alumni association, one at the college level and also at the department levels. These associations are quite active and organized 41 meetings in the last 5 years. The intellectual and financial contribution of the Alumni of this college is appreciable.

Bharata Mata College is a Christian minority institution established with the objective of spreading knowledge in the remote areas. As on this date, this college caters to the needs of both, rural and urban areas. The college has a well-defined chain of administrators including Patron, Co-Patron, Manager, and Principal. Participative decision making and transparent financial policy are the guiding principles of the management. The decision-making bodies are the Governing Body, IQAC and the College Council. Other statutory bodies are Internal Compliance Cell, Students' and Employees' Grievances Redressal Cells, Anti-Ragging Cell, Minority Cell, ST/ST Cell, and OBC Cell. These bodies ensure the smooth functioning of the institution. There is student representation in statutory and administrative bodies.

Participation of students, teachers, staff members, and other stakeholders in the decision-making process is ensured by the college administration.

The management has implemented a strategic plan 2015-18 for improving the infrastructure; innovation in teaching and research; engagement with alumni and stakeholders; involved and effective governance; and good practices with activities aligned with the core values and focal themes.

This college is managed by Bharata Mata Educational trust. Governing bodies and administrative set up are in place for the smooth functioning of the college. IQAC ensures the quality enhancement of the college in all aspects. An ERP has partially been implemented for taking care of the e-governance of the college. Various bodies of the college are working effectively as is evident from various minutes of the meeting etc.

This college has implemented a few schemes for the welfare of teaching and non-teaching staff. The college has implemented a performance appraisal system as per UGC format. The audit of government aids and other research grants is conducted regularly. The college has also laid down a plan for mobilizing the funds from other resources. The IQAC is active in conducting academic audits, some programmes, and also in participating in various ranking frameworks. There are a number of new initiatives that have been taken by the college in the last 5 years.

Bharata Mata College organized some programs for women in the last 5 years. The college is particularly sensitive for the security of female students and employees, the female to male ratio on the campus is 1.44:1. The college has a strict supervision in-place for the female students when they have to come beyond the college timings. A counseling cell has also been established in the college that helps the students when they face some kind of personal crisis. The college also has a sick room, a common room for female students, and some additional facilities required for the female students.

This college meets all its power requirements through renewable energy resources. The usage of LED bulbs seems to be on a lower side in this college.

The college has put in efforts to manage its solid waste, liquid waste and also the e-waste. The college has also worked on harvesting rainwater. The first rainwater harvesting system was implemented in the college in 2012.

Bharata Mata College has taken several measures towards making its campus as a green campus. They have restricted the use of motored vehicles between 9:30 am and 3:30 pm on the campus. The college is also moving towards having a paperless office. The college has also invested in the development of differently-abled persons on the campus.

This college organized 31 programs for the benefit of the local community, including quiz competitions and participation in the cleanliness campaign. A code of conduct handbook exists for the students and other functionaries of the college.

The college should strengthen its courses on human values and professional ethics. The college also actively organizes the national festivals and birth/death anniversaries of great Indians, including Republic Day, Independence Day, and Gandhi Jayanti, etc.

The college has a transparent administrative, academic and financial system. This college has also initiated two very good practices: one is about raising the funds and follow up the progress of selected cancer patients and the second is about psycho-social intervention in Brostal School inmates. This is organized by the students of the college.
